STRATEGIC GOALS – OPERATIONS

I. Watersheds Canada champions freshwater protection and stewardship

- Establish consistent external communications about program activities with the guidance of an annual communications plan.
- Develop and share annual reports, highlighting and summarizing the past year's work and next year's goals.
- Increase engagement of landowners, program partners and communities through use of appropriate technologies, ecological understanding and social approaches.
- Improve engagement and communication strategies to encourage active participation in local stewardship efforts, including media, digital communications, in-person engagement opportunities, etc.

II. Watersheds Canada cultivates a dedicated team of staff members, board members and volunteers

- Ensure competitive compensation and long-term contracts for staff by securing sustainable funding.
- Engage the board of directors to participate in program development and delivery, fundraising, promotions for the organization, in additional to regular board responsibilities for policy development and financial oversight.
- Capture the skills of the board of directors by creating board committees as required.
- Include volunteers to support and enhance staff capacity.

III. Watersheds Canada grows its financial resilience and organizational stability

- Develop funding models and long-term funding plans for programs, with a focus on diversity.
- Develop a sponsorship program to stimulate individual and privatesector donations.
- Explore feasibility of social enterprise models for appropriate programs.
- Grow fee-for-service aspects of existing programs where possible.
- Increase engagement of donors through use of appropriate technologies and regular communications.
